**RE: CORAL AND MAJESTIC PRINCESS AUSTRALIA DEPLOYMENT UPDATES**

Due to deployment changes and operational considerations, we are making some itinerary changes to the 2022/23 Coral Princess and Majestic Princess season from Australia, as we carefully and gradually return to service after an absence of more than two years. For select itineraries, these changes reflect the ongoing uncertainty regarding international cruise borders in some parts of the region.

We are also pleased to announce several new 2023 and 2024 itineraries on both Coral Princess and Majestic Princess.

## VOYAGE & ITINERARY CHANGES ON CORAL PRINCESS

### VOYAGE CHANGES ON CORAL:

Due to operational considerations and ongoing uncertainty regarding international cruise borders in some parts of the region, the 12-day Queensland and New South Wales Coast (voyage 6210Q) will now be split into a 5-day Sydney & Sapphire Coast Seacation voyage and a 7-day Queensland voyage. Additionally, the 12-day Queensland and the Conflict Islands (voyage 6214Q) will now be split into a 3-day Sapphire Coast Seacation voyage, a 4-day Moreton Island Seacation voyage, and a 5-day Hunter & Sapphire Coast Seacation voyage.

**Option 1:** Move to replacement voyages – this is the default option.

Passengers currently booked on the voyages below will be automatically moved to the equivalent replacement voyages (see table below). New booking confirmations will be sent by 30 June 2022 for guests on voyage 6210Q and by 7 July 2022 for guests on voyage 6214Q. Cruise fares and promotions will be protected. Any Princess shore excursions will be moved to the new voyages, if possible. No action is required from guests or Travel Agents for this move.

If guests choose to stay on these replacement bookings, they will also be given A\$50pp Onboard Credit per voyage as a goodwill gesture.

If guests would prefer to sail on other Princess voyages in the future, they will have two other options:

#### Option 2: FCC

- One Future Cruise Credit equal to 100% of the cruise fare paid
- Book by 31 December 2022 and sail by 31 August 2023

#### Option 3: Refund

- Refund to the original form of payment
- No price matching if the guest would prefer to rebook

Deadline for requests via the [online form](#): 30 June 2022.

If guests have not contacted Princess by 30 June 2022, they will be automatically moved to the equivalent replacement voyages.

The new replacement voyages 6210R and 6210S will be open publicly on 30 June 2022 at 4:00 pm PDT / 1 July 2022 at 9:00 am AEST and the new replacement voyages 6214R, 6214S and 6214T will be open publicly on 7 July 2022 at 4:00 pm PDT / 8 July 2022 at 9:00 am AEST.

## **CANCELLED VOYAGES ON MAJESTIC PRINCESS**

As a result of the new voyages, voyages 8307N, 8307A, and 8307B will be cancelled. Guests booked on a cancelled voyage (see table below) will have 3 options:

**Option 1:** Princess will offer to move guests to an equivalent cruise (see replacement voyage list). The rebooking offer will have the benefit of protecting the guests' current fares and promotions on their recommended replacement cruise in the event the new cruise fare is higher. The new booking will be in an equivalent category, subject to availability.

**Option 2:** FCC – This is the default option.

- One Future Cruise Credit equal to 100% of the cruise fare paid
- Book by 31 December 2022 and sail by 30 April 2024

**Option 3:** Refund

- Refund to the original form of payment
- No price matching if the guest would prefer to rebook

Deadline for requests via the [online form](#): 20 July 2022.

If guests have not contacted Princess by 20 July 2022, they will automatically be given an FCC. FCCs can be used on any cruises booked by 31 December 2022 and that sail by 30 April 2024. Guests should not be held to taking an FCC if they want a refund.

### **Commission Protection & Bonus Commission**

Commission is being protected for bookings paid in full (as defined by having a date in the paid in full field in Polar).

An e-mail and/or booking notification will be issued to inform guests booked on these cruises and Travel Agents holding group allocations of the cancellations.
